Some notes on ova imports and Aquagen

60.2 million salmon ova imported into Scotland in 2019 (figures from health certificates) - 26.3 million from Iceland (Stofnfiskur), 23.7 million from Norway (Aquagen, Grieg Seafood Rogaland and Mowi Norway) and 10.2 million from Republic of Ireland (Mowi Ireland).

We have not received any consignments from Norway since May 2019. The number of ova imported from Iceland in 2019 has increased to fill the gap caused by the issues in Norway (increased from 10.1 million in 2018 to 26.3 million in 2019).

Aquagen now have a salmon hatchery in Dumfries, Scotland (Holywood Breeding Centre) which they will use to supply Scottish industry (not sure if this will be exclusively or if there will be some imports from Aquagen Norway as well to Scottish industry, will depend on demand). <REDACTED> – Out of scope

As we discussed, some industry members expressed concerns, over uncertainty with the subject in matter, as a result I thought it would best to ask DEFRA to seek an update from Norwegian authorities if possible. We would be grateful if you can

seek clarity and provide further information on the ISA free compartment list and when the competent authority will resume issuing certificates for exports.

I guess the main question to ask is if they expect to put forward the ISA free list for consideration and open up trade in the meeting next week or in any of the following meetings e.g April meeting? Are they seeking approval from SCoPAFF that they have fully implemented corrective measures or is this just an update on their progress?

Also is the EFTA audit completed (still scheduled until April?).
Also grateful if you can let me know if there is any forward visibility regarding which compartments will be put forward.

Any help/assistance you can provide would be greatly appreciate.

Good afternoon <REDACTED> <REDACTED> and colleagues

The Ferret has asked about a ban on Salmon egg imports to Scotland from Norway following a Scottish Salmon Watch FOI request.

The reporter is looking for SG comment on SSW's claim that Icelandic ova has been problematic and 'have history of disease problems' and asking 'could you also say how this ban has affected fish production due to Scotland's reliance on Norwegian imports?'

SSW Say

"A staggering 99% of co-called 'Scottish' salmon is actually controlled and owned by foreign companies with 65% under Norwegian control. The ban on ova imports from Norway is a slap in the face for Norwegian companies exploiting Scotland's wild image. It beggars belief that Norway bans imports of Scottish ova **yet the Scottish Government are falling over themselves to import ova from countries (eg Iceland) with a history of disease problems.**"

Have enclosing previous lines from a similar inquiry last week (Mail on Sunday Fol) as a starting point.

This covers the question re Norwegian ban's effect on production, so would propose reissuing, but with new line to address the question of any issues with Icelandic ova.

PREVIOUSLY ISSUED STATEMENT

A Scottish Government spokesperson said:

"We are confident Scotland has access to an adequate supply of salmon ova.

"Since the suspension of imports from Norway, AquaGEN's investment in a salmon hatchery in Dumfries and Galloway has come on stream, supplying 50% of Scotland's ova needs.

"In addition to that, Scottish fish farmers continue to use their own broodstock and we are importing more ova from elsewhere, including Iceland.

"We are, however, monitoring the situation very closely and continuing to press Norway to resolve this matter."

FULL MEDIA INQUIRY

Further to call, I'm writing a story for The Ferret based on new information from Scottish Salmon Watch via a FOI request. Our story is that -

Salmon egg imports to Scotland from Norway have been banned due to the risk of a devastating viral disease spreading called Infectious Salmon Anaemia (ISA), we can reveal.

Millions of salmon eggs, aka ova, have been imported from Norway to Scottish salmon farms and hatcheries in recent years, with Scotland heavily reliant on Norwegian imports.

Both the Scottish and UK governments have expressed concern over ISA, however, and new documents reveal that exports of Norwegian ova were banned last June following an inspection by the European Free Trade Association's Surveillance Authority.

The ban remains in place because, according to the Scottish Government, "Norway is unable to ensure that farmed fish/shellfish sent for export to other EEA states will not affect the health of farmed fish/shellfish in those receiving countries".

ISA is an infectious viral disease of Atlantic Salmon. The disease was first reported in Norway in 1984, but has since been reported in Canada, the USA, the Faroe Islands, Ireland and Scotland. Both outbreaks of ISA in Scotland in 1998-99 and 2008-09 were successfully eradicated.

There are no treatments for ISA and it can cause severe losses to infected farms.

Hundreds of thousands of fish have previously been slaughtered in bids to control outbreaks of ISA, with affected fish farms disinfected and placed under close surveillance.

Scottish salmon production is heavily reliant upon the import of Norwegian ova with 90 per cent of ova imports coming from Norway, according to the Scottish Government.

The documents were released after a freedom of information request by Scottish Salmon Watch.

They reveal that in 2018 Scotland imported 48 million salmon ova from Norway and nearly 24 million in 2019," according to an internal Scottish Government memo in October 2019.

In 2018, Scotland imported 66 million ova with 48.3 million from Norway, 10.1 million from Iceland and 7.3 million from the Republic of Ireland.

The ban on ova exports from Norway in June 2019 led to zero Norwegian imports of ova to Scotland after a shipment to Mowi on 22 May 2019. All shipments after that

date - at least up to the end of 2019 when data is available - were from Icelandic firm, Stofnfiskur.

"Salmon farming is a disease-ridden nightmare," said Don Staniford, Director of Scottish Salmon Watch. "Discerning consumers will be shocked to discover that the vast majority of 'Scottish' salmon marketed in glossy advertising by supermarkets is actually sourced as eggs from Norway, Iceland and Ireland. Iceland has now become the #1 importer of ova for use on Scottish salmon due to disease risks in Norway. The ban on imports of ova from Norway should be extended to other countries to protect the genetic integrity of Scottish salmon."

"A staggering 99% of co-called 'Scottish' salmon is actually controlled and owned by foreign companies with 65% under Norwegian control. The ban on ova imports from Norway is a slap in the face for Norwegian companies exploiting Scotland's wild image. It beggars belief that Norway bans imports of Scottish ova **yet the Scottish Government are falling over themselves to import ova from countries (eg Iceland) with a history of disease problems.**"

Could you send a comment by 5pm today please, in reply to SSW's claim that Icelandic ova has been problematic as well? Could you also say how this ban has affected fish production due to Scotland's reliance on Norwegian imports?

Sorry for the delay with this but we've now heard back from Norway regarding an update on the ova suspension.

They have informed us that they've been in a process of carrying out a comprehensive evaluation of all of their previously Declared ISA-free zones and compartments in order to rule out all possible misunderstandings and lack of fulfilment of the requirements set out in Commission Decision 1554/2015. This process is now in its final stage, and a conclusion will be reached within a few days.

Therefore, they've said that at the moment they're not able to give more details on which compartments will be reintroduced on their list, but will provide more information as soon as the final decision is made.

I will let you know as and when we receive more information.

Please find information below regarding the Norwegian self-imposed suspension of health certification of live aquaculture animals from certain ISA-free zones and compartments.

They have now confirmed that the Norwegian Food Safety Authority has decided to lift the suspension for the following compartments as from 6th March 2020:

- Compartment 18000 - Rimstad, Company AquaGen
- Compartment 12917 – Sjølseng – Hall 6, Veksthall 1 og 2, Company AquaGen

- Compartment 12917 – Sjølseng - Hall 2, Company AquaGen

Consequently, live ova produced at those compartments will from now on be certified for export to UK.

We welcome the decision by the Norwegian Food Safety Authority to lift their self-imposed suspension of health certification of live aquaculture animals from certain ISA-free zones and compartments from 6 March 2020. This means live ova produced in specific compartments can now be certified for export to Scotland.

If you recommend an update - perhaps we should say something along the following lines:

“Further to my advice contained in the submission, we have just learned that it is unclear what volume of ova will be traded from the compartments declared free.

The Sjolseng compartment is a new area, and we have no knowledge of the volume of ova which may be available to be supplied. The Rimstad compartment has historically supplied variable volumes of ova to Scotland.

Although the announcement is most welcome, Scotland may still have to rely upon domestic production and supply from other international sources for the next ova season or two until further compartments are declared disease free.”

Whilst the announcement is welcomed, it is unclear what volume of ova will be traded from the compartments declared free – the Sjolseng compartment is a new area, we have no knowledge of the volume of ova which may be available to be supplied. The Rimstad compartment has historically supplied variable volumes of ova to Scotland.

Bear in mind that the supply of ova to Scotland, as a percentage of ova required for domestic production in Norway, is relatively small, single digit percentages only.

Depending upon how quickly other compartments are declared disease free, Scotland may still have to rely upon domestic production and supply from other international sources for the next ova season or two.

“Since the suspension of imports from Norway, new salmon hatchery facilities have come on stream in Scotland which were able to supply some of Scotland’s ova needs. The Scottish Government will continue to support the increased production of ova here in Scotland. In addition, Scottish fish farmers continued to use their own broodstock and were able to import further supplies from countries which operate within approved zones free from listed disease. As a result we don’t expect any impact on production to arise in 2021 or 2022.

“The Norwegian Food Safety Authority (NFSA) lifted its self-imposed suspension of health certification of live fish, ova and gametes from a number of ISA-free zones and compartments in March 2020. We have been asked to supply information about the supply of salmon ova Scotland and the gradual lifting of the ova ban from Norway (please see full query below).

Grateful if you can suggest lines to respond to this query. I have included lines issued previously on this matter, which appear to predate the lifting of the ban.

Grateful also if you can extend the copylist if I missed any key officials.

Query

I am currently writing an article for the Advocate - run by the Global Aquaculture Alliance – on the situation with salmon ova supply in Scotland, and would like to speak to someone to understand how the gradual lifting of the ova ban from Norway is being managed and notified, or to receive a quote about the situation.

Previous lines (issued Feb 2020)

A Scottish Government spokesperson said:

“We are confident Scotland’s aquaculture industry has access to an adequate supply of salmon ova and don’t expect any impact on production in 2021 and 2022.

“Since the suspension of imports from Norway, new salmon hatchery facilities have come on stream in Scotland, supplying much of Scotland’s ova needs. In addition, Scottish fish farmers continue to use their own broodstock and are importing more ova from elsewhere, including Iceland which operates within an approved zone free from listed disease.

“We are, however, monitoring the situation very closely and continuing to press Norway to resolve this matter.”
