Not sure who locally best placed to link in with [redacted] @ ScottishSalmon, but attached should give you the background to the incident.

Very briefly – fish feed barge sank at Portree on 27th November. All fuel was removed and the feed silos were sealed up by welding plates over the lids. ScottishSalmon have been out to tender for the next element of salvage of the feed barge, which is planned to be undertaken once cages have been harvested. The below is an outline of some of the options presented for recovery of the feed ahead of barge being lifted – I believe Scottish salmon had sealed the feed tanks as they thought the whole thing could be lifted without removing the feed (you [redacted] recall one of the other barges spent time pumping out and shuttling to shore, which was extremely expensive but ensured minimal chance of large nutrient dump and eutrophication issues). To lift all intact will require larger crane barge etc than it would if only lifting an empty barge (though this are quite heavy vessels as concrete construction).

This will be a question for Marine Scotland and SEPA – as it would be a deposit in the sea and also comes under waste management. Discharging the waste to sea would be discharging a relatively large quantity of nutrients (approx. 350tonnes of feed) into the water (which sealing the storage tanks was designed to mitigate). I have copied into the email points of contacts within the regulatory authorities that will be able to assist in your enquiry.

Afternoon

Apologies another question we have had from the tender can you advise?

Since the fish feed is an organic matter, likely not harmful to the sea or wildlife, this project offers some extra scenarios of how to handle the cargo compared to other

wreck removals with bulk cargo disposal. All is of course dependent on what is approved/accepted by the Authorities. We foresee the following scenarios for handling the cargo:

1. Pumping cargo and direct discharge by floating hose near the wrecksite.
2. Pumping cargo to hopper dredger and discharge all cargo at a designated area.
3. Pumping cargo to Platform Supply Vessel and discharge to a shore facility (resulting in extensive tank washing).
4. Pumping cargo to a filtering system, dry captured bulk to be discharged to onshore facility by container (resulting in a time-consuming logistics challenge)

Dear all

Please see the update in the email thread below. In summary hydrocarbons and other pollutants accessible by divers will be removed in the next few days. The approx. 350tonnes of feed onboard will be sealed into the silos and dealt with at a later time when the barge is lifted (salvors are being consulted at this time) – which is likely to be March 2022 when cages will be fallow.

Given the depth and tidal flows in the area any leeching of nutrients is likely to be distributed over a relatively wide area in very small quantities.

The barge reportedly sank on its moorings, and has impacted the seabed substrate (reportedly sand/mud) at an angle and is submerged approx. 800mm. The following images give you an indication of what the barge looked like before it sank – construction is largely concrete.

Items 1 – 3 will be carried out once underwater visibility has improved, Item 4 will be Next week target for completion.

1. Recovery of 3 x oxygen packs
2. Recovery of kerr mobile compressor
3. Recovery 1 x 1500litre fuel cube
4. Plates to be manufactured and fitted to seal the feed silos

[redacted] our Head of Engineering will head up the salvage operation from our end and will send out any updates going forward.

At the moment we have recovered all the shore line debris, 1 fuel cube (still full of fuel) and the external generator from the sea bed. Focus now moves to recovering the fuel from the internal fuel tank, which we hope to complete this week.

We have also been liaising with our insurance company on the salvage operation itself, but this will take some time to get in place.

As things stand, we see no danger to shipping and the barge is secure within our site boundaries.

All fish pens and nets have been checked and remain secure and fully operational.

Evening All

Update from today the divers have now recovered the final missing fuel cube. I am trying to confirm all the fuel was recovered with it I will confirm tomorrow morning.

We have seen some early signs of feed oils reaching the surface and also identified seepage from 1 silo which we believe is the source. The weather looks better tomorrow and the site team will send photos and an update on this. Briggs have provided us with an environmental plan should we require to mobilise this. The document is attached.

The forth Constructor is now in Kyle of Lochlash and will be onsite 0800 tomorrow to start work on sealing the vessel to contain any feed oils, We are awaiting Confirmation from Briggs on how long this will take, we believe we will have a better idea of timescales once the work has started. The focus will be the silo showing seepage followed by the rest of the areas. I will also ask them to check the other silos daily for signs of any Feed oil escaping. Should this deteriorate I will inform SEPA and the MCGA straight away.

We have started to look at the recovery plan and will be pulling the tender documentation together for this over the next few days along with our insurance provider, with a view to get those quotes and plans looked over and the contract awarded.

Once we have this plan in place I am proposing to have a teams call with all in copy to give detail on that plan and the proposed dates to execute it.

2. Leco marine are looking to retrieve the last fuel cube tomorrow this has been delayed due to weather and visibility at the location of the fuel cube.
3. The forth constructor is currently heading to site and that vessel is due on site Tuesday to start work on sealing the barge to prevent feed seeping out.
4. Briggs marine are looking at a method of removing the feed from the barge and those plans are ongoing.
5. We are seeing signs that the feed is starting to degrade hence the urgency to get the vessel to site to start sealing the barge.

Dear all

Yesterday (Tue) the divers recovered the final missing fuel cube, site confirmed that the fuel cube was recovered full.

There are some early signs of feed oils reaching the surface from one silo which is believed is the source. The observations were seen to surface directly above the site so far. The weather was fairly calm when this was observed so it will be good to see what they find onsite today. Site team will send photos of surface and an update on this.

See below photos of the release. On the first picture you can see the release coming from the feed silo and in the second faintly. This appears to be coming from one feed silo only at present. There are no photos from the surface as no one is on site due to the weather. They have said they will send these through ASAP once they get back out to site. There is no sign of hydrocarbons (fuel & Oil)



Pictures of the other silos no signs of any release as yet



Briggs have provided an environmental plan. [redacted]

They will be asked to check the other silos daily for signs of any Feed oil escaping. Should this deteriorate SEPA and the MCGA to be informed straight away.

The forth Constructor is now in Kyle of Lochlash and will be onsite today to start work on sealing the vessel to contain any feed oils, Awaiting confirmation from Briggs on how long this will take, believe will have a better idea of timescales once the work has started. The focus will be the silo showing seepage followed by the rest of the areas.

Recovery plan is being developed and pulling tender documentation together for this over the next few days. Once this plan is in place proposed to have a teams call to give detail on that plan and the proposed dates to execute it. Three options which are being discussed and prepared for tender:

Option 1 to stop any further feed oil being released, Mobilise the plan to lift the barge as soon as practicable. (fish stock welfare needs to be considered)

Option 2 monitor and plan to remove the barge in March / April If possible

Option 3 plan the removal of the feed, look to recover the barge in March / April

Current preference of Scottish Salmon would be to seal the barge as planned then lift the barge out of the water and take it to a facility to have the barge assessed and waste feed etc removed to reduce the risks associated with onsite removal.

Appreciate the updates we have been receiving.

In relation to the update below it would be useful to have a little more detail on the reported surface pollution:

I note the reference to the feed degrading and the fuel cell remaining unrecovered – has there been any signs of pollution other than ‘film’? What is meant by a film – is this a thin sheen colour or a film of feed dust/particles? Any signs of hydrocarbon release (fuel or lub oil)?

What is the extent of coverage and the position it is centred on (presume it is immediately above the feed barge, but if surfacing some distance away it would be useful to have the location of where any pollution is being observed)? Is the film seen to be persistent and/or constantly surfacing? It would be useful to understand the context of the weather on scene – is it a relatively sheltered site or would you have expected the weather to be breaking up the surface contamination?

It would be extremely useful to have access to any images of the surface pollution and any captured of the wreck itself.

Now that there have been a number of visits to the site, in addition to the Briggs pollution plan, I would be grateful if you could share any plans you have now developed in terms of recovery of the feed and barge – is it still your intention to seal the barge silos and lift the barge with the feed still held in the barge, or are there any intentions to deal with the feed separately to the barge lift? If the feed is to be recovered from the barge ahead of the lift I would be grateful for details of the methodology and outline of how the waste feed will be handled/disposed.

Thank you for taking my call.

As discussed, you mentioned that the feed had been seen by the divers as leaking from the barge and there is now a 'film' on the sea surface.

We appreciate the efforts that have been made so far to mitigate any environmental impact. It was expected the feed would start to decompose and begin to leech into the marine environment, but obviously we weren't sure exactly when this would happen. As you have advised there is now a 'film' on the sea surface, this would seem to suggest there is a higher level of nutrient in the water column, which is one of the concerns the environmental agencies had. I have copied into this email Marine Scotland, who are the Chair of the Scottish Environment Group so they are aware of this update.

You have advised that it is still your intention to seal the feed silos, whilst continuing to look at full barge recovery. Recognising the weather warnings in place for the next 24 hours, and the time of year, it's expected the sealing of the silos could take a few days / weeks due to safety concerns.

You advised you were in direct contact with SEPA who are due to get back to you regarding any regulatory instruction in terms of feed recovery / removal to assist with the insurance question noted below.

You also advised Briggs Marine had developed a pollution response plan. If you would be able to send myself and those in copy, a copy of this plan, we will be able to provide you with any further advice and / or seek any clarification. If you are also able to send a copy of any images of the 'film' on the surface, that would be appreciated. Once you start to develop the recovery of the barge, please ensure those copied into your updates are kept appraised, so we can monitor the progress and pose any questions.

Morning [redacted],

We had an incident last week with a fish farm feed barge sinking on its moorings off Portree in 36m of water (Scottish Salmon Company). I've attached the incident log sheet however the key points are as follows:

- Most of the fuel has been recovered. There is still a 1000L fuel cube of diesel onboard which has not yet been located.
- The fish feed is contained in silos which they are in the process of sealing. The plan is then to leave these onboard until the barge can be recovered.
- Dive teams are working to seal the silos and locate the remaining fuel cube.
- They are not planning to recover the barge until March 2022 when the site is next fallow.
- There was no significant pollution other than large pieces of plastic which have been recovered. No organisations have concerns while this remains the case.

I've created an incident folder in the inbox for it where you can find all the emails however at the moment, I think it's just a case of monitoring the regular update emails from the MCA to check for nothing untoward. [redacted] is aware.

I also contacted Food Standard's Scotland yesterday to check if there were any shellfish harvesting areas nearby that we needed to be aware of. They have come back (see attached email) to say that there is a cockle bed 2.3km from the vessel within Loch Portree. They have notified the operator for awareness however have no concerns at the present time. If there are any significant updates in relation to the incident then we should ensure they are informed.

Good news that they are getting the fuel off. Have we seen any plans for the removal of fuel to be satisfied that they have appropriate spill measures in place?

In terms of the feed, I had a quick chat with [redacted] and I believe there have been issues in past incidents where the feed has become solidified and much more difficult to deal with following water ingress however I assume this has been considered by the operator in deciding to leave it in situ? Have we seen any plans or considerations with regards to this?

I appreciate it's a while away however, it would also be helpful to be involved in the discussions regarding the plans for the lifting of the barge once they have been formed.

Please see the update in the email thread below. In summary hydrocarbons and other pollutants accessible by divers will be removed in the next few days. The approx. 350tonnes of feed onboard will be sealed into the silos and dealt with at a later time when the barge is lifted (salvors are being consulted at this time) – which is likely to be March 2022 when cages will be fallow. Given the depth and tidal flows in the area any leeching of nutrients is likely to be distributed over a relatively wide area in very small quantities.

The barge reportedly sank on its moorings, and has impacted the seabed substrate (reportedly sand/mud) at an angle and is submerged approx. 800mm. The following images give you an indication of what the barge looked like before it sank – construction is largely concrete.

As you are aware, from our ongoing correspondence with you, we have been carrying out lifting and fish feed removal works on the sunken feed barge at Portree

As previously advised and predicted we have readings and samples, from our contractor, that suggest that the feed remaining and sealed in the barge, has begun to naturally decompose and is producing gas. Our investigations to date would suggest that the gas is Hydrogen Sulphide. There also appears to be a small leakage of gas through the concrete wall of a feed silo. As a result of those investigations and to ensure that the issue is dealt with swiftly, we have taken the safety precaution of pausing operations, while our contractor and specialist advisors assess and determine the appropriate technical and safe operational solutions

Our advisors are making use of various risk management/guidance materials, including the internationally recognised '2020 Emergency Response Guidebook'

Given the nature and the scale of works undertaken to prepare for the recovery operation, we have put an exclusion zone in place and a Notice to Mariners has been issued for the site on that basis. We will now extend the active time period for the Notice to Mariners

Additional monitoring will be put in place as a priority, and our contractor and specialist advisers are expecting to update on readings and technical advice daily

We will provide a further update once the recommended course of action has been determined by our contractor and specialist advisers

Following from my previous email, from our ongoing correspondence with you, we have been carrying out lifting and fish feed removal works on the sunken feed barge at Portree

We have had a dive team onsite today to carry out some works to prepare for the venting of the barge; sample readings were taken by our specialist contractor during this operation, which have registered high levels of H2S within one of the sealed silos (55,000 ppm) and low levels on the site (2 ppm), due to the small amount being released at present. The team are working on a solution to introduce an inert gas during the venting portion of the operation to reduce risk. We are working to carry out this operation out as soon as possible given this latest information.

Given the nature and the scale of works needing to be undertaken to prepare for the recovery operation, we will put an exclusion zone in place and a Notice to Mariners will be issued advising of this, we hope to have this updated today with assistance from the Harbour Master. Additional monitoring can only be carried out while the dive vessel is onsite, and our contractor and specialist advisers are expecting to update on readings and technical advice daily

We will provide a further update once the venting works by our contractor and specialist advisers is ready to begin.

As discussed, I just wanted to check with you that the local emergency services, namely fire and rescue for their HAZMAT expertise, and the local authority are actually aware of this newly identified issue, and they understand what it means. Whilst these email updates are valuable and helpful, unless you have a positive response back, its not possible to confirm who has read (and understood) them, and what action has been taken to mitigate any risks. If you could attempt to speak to the local representatives (fire and authority) to ensure they are in receipt of this information and understand it, that would be appreciated.

You mentioned there is a local footpath not too far from site, which could be impacted, but was unsure what measures the Local Authority had put in place to deal with this. You also mentioned that cruise liners do transit near the area (although not expected until late next week), but you advised the HM is aware of this and will give notice to any cruise liners coming in to give the area a wide berth.

Following from my previous email, from our ongoing correspondence with you, we have been carrying out lifting and fish feed removal works on the sunken feed barge at Portree

We have had a dive team onsite today to carry out some works to prepare for the venting of the barge; sample readings were taken by our specialist contractor during this operation, which have registered high levels of H2S within one of the sealed silos (55,000 ppm) and low levels on the site (2 ppm), due to the small amount being released at present. The team are working on a solution to introduce an inert gas during the venting portion of the operation to reduce risk. We are working to carry out this operation out as soon as possible given this latest information.

Given the nature and the scale of works needing to be undertaken to prepare for the recovery operation, we will put an exclusion zone in place and a Notice to Mariners will be issued advising of this, we hope to have this updated today with assistance from the Harbour Master. Additional monitoring can only be carried out while the dive vessel is onsite, and our contractor and specialist advisers are expecting to update on readings and technical advice daily

We will provide a further update once the venting works by our contractor and specialist advisers is ready to begin.

In the meantime, if there is any further information that you require then please do not hesitate to contact me.

I just wanted to give you a quick update in regards to the Portree Barge gas venting following the call this afternoon.

The key updates are as follows:

- Earliest timeframe for reducing gas on site is next Monday (29 August 22) as this is the earliest a vessel can arrive at site in order for nitrogen to be provided. May be worth briefing [redacted] on this incident as he is on rota next week.
- No change to barge condition and no increase in gas being released but gas bubbles still coming up to the surface.
- No change to alarms
- Site patrols – all going well. The use of guard vessels is working well.
- Dives – the dives have started on site to begin laying down hoses to remove gas from barge.
- Clearance for nitrogen to be used on vessel causing delays. MCA to be contacted for update on this.
- Water sampling. One sample was taken yesterday and another one is due to be taken today.
- Next meeting: Monday approx at 3pm but no confirmation has been sent.

There were some discussions in terms of worst case scenario. Should the barge explode mitigations are in place to protect public health. Rest centre for those inside sectors that could be impacted should the gas come to shore will be set up at Portree High school. The council offices would be used for emergency response centre. Public health will advise that people close windows and doors as well to protect themselves should the gas reach shore. There was no mention of potential environmental impacts for this scenario.

It was good speaking to you.

Below is a brief overview of what's been going on and I've attached the method statement for your attention.

The Seamate 450 fish feed barge owned by the Scottish Salmon Company sank during the tail end of 2021 in Portree Harbour, Isle of Skye with approximately 400t of feed on board.

Preliminary diving work started in July 2022 where bubbles were observed during the relief of the gas and oils from the silos. It became apparent that the gases were toxic in composition with Hydrogen Sulphide and Methane. Air gas monitors have been placed in ten locations surrounding the site and remotely monitored 24 hours a day to allow for early warning of any large release. The incident is very much public health focused, with little environmental impact discussed.

As far as I'm aware; there has been no change to the barge condition and no increase in gas being released, however gas bubbles are still being observed coming up to the surface.

I'm looking to see if you have any further input regarding environmental impacts in the area, such as; any seal haul out sites in the area to the east of Portree, under the cliffs that may be impacted if a catastrophic release were to happen.

Marine Scotland has been liaising with Police Scotland and local authorities regarding the safety/exclusion zone approximately 2km from Portree, Isle of Skye. The safety/exclusion zone is connected to the sunken barge belonging to Bakkafrost Scotland which sank on the 27th of November 2021.

Initial salvage operations successfully removed the diesel from the fuel tanks, cleared the superstructure and the hatches and silos on board were sealed to prevent the release of the fish food on board. The sealed hatches have allowed the build up of gases which would otherwise have been released.

To prevent risk to the public and the environment, an exclusion zone is in place for the slight risk of toxic gases escaping. Guard vessels and gas monitors are monitoring the site 24 hours a day to provide an early warning of any release of gases whilst salvage operations are ongoing. It is proposed that gases will be flushed with nitrogen from the structure in a controlled release which will not pose any health risk before the structure is recovered

I don't see any correspondence of it being an exclusion zone, so would safety zone be used instead? Not sure if it is a statutory or advisory safety zone can you find notice to mariners? Safety zone is probably better

- Still no detection of gases escaping
- Anticipated timeline of recovery of the barge is middle of October – dependent on how venting operations go

- No date for the follow up meeting – Bakkafrost will send out an updated invitation once they're happy venting can go ahead

A Bakkafrost Scotland spokesperson said:

“Bakkafrost Scotland can confirm the successful and safe completion of the initial recovery stage of venting gas from the submerged feeding barge at the Portree farm site, which was damaged during Storm ‘Arwen’ in November 2021.

“Throughout the recovery process we have been working closely with the relevant authorities including SEPA, Marine Coast Guards and Fire Brigade, alongside other experts, and we are now progressing to the next stage of the operation which will include lifting the barge.

“An exclusion zone was in place as a precaution throughout the venting operation and a ‘Notice to Mariners’ was issued on 5 August to ensure all affected were advised of the incident.

“The relevant authorities are being kept informed of progress and we will work with the recovery experts to ensure a safe conclusion to the operation.

“Bakkafrost Scotland is fully committed to ensuring public safety in relation to all of its operations, vessels and equipment.”
